Boxwood Provides:

Boxwood is a treatment program of Encompass Community Supports that provides residential substance use disorder treatment for individuals, 18 years of age or older who reside in Culpeper, Fauquier, Madison, Orange and Rappahannock counties. Referrals from other counties throughout Virginia, through their Community Service Boards (CSBs), are also welcome.

Services Include:

- Individual treatment planning
- Tuberculosis (TB) screening
- Full range of lab work
- Comprehensive substance use assessment
- Group counseling
- Educational multi-media
- Presentations/lectures
- Individual counseling
- Discharge planning and referrals

Boxwood is a 28-day residential treatment program for adults. However, we are able to accommodate requests by CSBs for other lengths of stay, based upon an individual's needs.

Fees:

Fees are determined by the referring CSB. Individuals may be eligible for assistance.

Boxwood accepts Medicaid insurance only.

Admission Criteria:

1. Individuals must be medically stable and not requiring continuous medical supervision/care.
2. A drug screen is completed upon arrival at Boxwood.
3. Individuals who take medications must bring a 28-day supply in their original, non-expired prescription containers.
4. Individuals are responsible for the costs of any medications prescribed by Boxwood's attending physicians.
5. Individuals who are pregnant must have documentation indicating the pregnancy is stable. Boxwood will not admit after the 6th month of pregnancy (2nd trimester).
6. Individuals must arrange for transportation to and from Boxwood.



Population Served:

Individuals requesting treatment must be assessed by their local Community Services Board (CSB).

We accept dually diagnosed clients with substance use disorders and/or mental health conditions.

We are also able to provide services to pregnant females, IV drug users and persons diagnosed with HIV/AIDS. These individuals are given priority status.

Boxwood desires copies of any discharge summaries, assessments, physicals, or other documents related to previous treatment.

Boxwood needs to evaluate further individuals who:

- Are experiencing symptomatic psychiatric instability
- Need specialized medical care
- Are at high risk for withdrawal symptoms
